The agenda of external actors often includes a number of objectives that do not necessarily and automatically go together. Fostering security and stability in semi-authoritarian regimes collides with policies aimed at the support of processes of democratization prone to conflict and destabilization. Meanwhile, the promotion of national self-determination and political empowerment might lead to forms of democracy, partially incompatible with liberal understandings. These conflicting objectives are often problematized as challenges to the effectiveness of international democracy promotion. This book presents systematic research about their emergence and effects. The contributing authors investigate (post-) conflict societies, developing countries, and authoritarian regimes in Southeast Europe, Latin America, Africa, and Asia. They identify the socio-economic and political conditions in the recipient country, the interaction between international and local actors, and the capacity of international and local actors as relevant for explaining the emergence of conflicting objectives. And they empirically show that faced with conflicting objectives donors either use a 'wait and see'-approach (i.e. not to act to overcome such conflicts), they prioritize security, state-building and development over democracy, or they compromise democracy promotion with other goals. However, convincing strategies for dealing with such conflicts still need to be devised. This book was published as a special issue of Democratization.

Assaults on democracy are increasingly coming from the actions of duly elected governments, rather than coups. Backsliding examines the processes through which elected rulers weaken checks on executive power, curtail political and civil liberties, and undermine the integrity of the electoral system. Drawing on detailed case studies, including the United States and countries in Latin America, Eastern Europe, and Africa, the book focuses on three, inter-related causal mechanisms: the pernicious effects of polarization; realignments of party systems that enable elected autocrats to gain legislative power; and the incremental nature of derogations, which divides oppositions and keeps them off balance. Like the postcolonial world more generally, Southeast Asia exhibits tremendous variation in

state capacity and authoritarian durability. *Ordering Power* draws on theoretical insights dating back to Thomas Hobbes to develop a unified framework for explaining both of these political outcomes. States are especially strong and dictatorships especially durable when they have their origins in 'protection pacts': broad elite coalitions unified by shared support for heightened state power and tightened authoritarian controls as bulwarks against especially threatening and challenging types of contentious politics. These coalitions provide the elite collective action underpinning strong states, robust ruling parties, cohesive militaries, and durable authoritarian regimes - all at the same time. Comparative-historical analysis of seven Southeast Asian countries (Burma, Indonesia, Malaysia, the Philippines, Singapore, South Vietnam, and Thailand) reveals that subtly divergent patterns of contentious politics after World War II provide the best explanation for the dramatic divergence in Southeast Asia's contemporary states and regimes.

This book discusses how the extension of voting rights beyond citizenship (i.e., to non-national immigrants) and residence (i.e., to expatriates) can be interpreted in the light of democratization processes in both Western countries and in developing regions. It does so by inserting the globalization-specific extension of voting rights to immigrants and expatriates within the long-term series of historical waves of democratization. Does the current extension enhance democracy by granting de facto disenfranchised immigrants and emigrants political rights or does it jeopardize the very functioning of democracy by undermining its legitimacy through the removal of territorial and national boundaries? The book offers a preliminary synthesis in a broad comparative perspective covering both alien and external voting rights in Europe, Sub-Saharan Africa and Latin America. More specifically, the volume aims to: promote critical discussion on the concept of populism, reflecting on its conceptual 'usability' beyond the traditional party families to which it is usually related; use a preliminary theoretical clarification to shed new light on the different ways in which populism has been articulated in the various European countries (either in Continental and Southern Europe, or in the lesser known and studied East-Central countries) since the economic crisis, which has acted as an external shock for many party systems, either giving birth to new political actors or consolidating existing ones; investigate the connections between populism and the national contextual political and cultural specificities that can determine the development of different types of populisms across countries, elaborating on different 'configurations' of triggering conditions for populism and reflecting on the limitations of a discrete conceptualisation of the phenomenon. Modern democracy is organized as a representative democracy in which those representing the people are elected to office. Political parties play a crucial role in this. They select the candidates, form or oppose governments, and organize the work of the representatives in parliament. This model of democracy is however being criticized. Parties are hardly trusted and voters have become volatile. How, then, do elected representatives of the people see and fulfil their role? To study this a survey was organized among the members of statewide and sub-state parliaments in fifteen countries. Members of seventy-three parliamentary assemblies were asked how they perceive their representative role, what they do to keep in touch with voters, how they behave and vote in parliament and how they will try to get re-elected. One of the ways in which candidates and elected members of parliament might react to the changing conditions in which they have to represent the people is by stressing more personal characteristics as opposed to the party label and party ideology. Representation might then become more a matter of personal choice. The results of the survey presented in this book do however confirm quite strongly that representation is very much shaped by the political institutions in which it is performed. Representation differs between countries, between different electoral systems, between statewide and regional parliaments, and depends strongly on the party to which a member of parliament belongs. Representation depends not as much on who the representatives are, as on where they are.

In an in-depth comparative analysis, Stefano Bartolini studies the history of socialism and working-class politics in Western Europe. While examining the social contexts, organizational structures, and political developments of thirteen socialist experiences from the 1860s to the 1980s, he reconstructs the steps through which social conflict was translated and structured into an opposition, as well as how it developed its different organizational and ideological forms, and how it managed more or less successfully to mobilize its reference groups politically.

While Americans' high ideals are often illusive in the rough and tumble of political battles, and the public's trust is bruised with every political scandal, balancing idealism and individual virtue with ambition and self-interest is the dynamic and safeguard of American politics. *How American Politics Works* offers a comprehensive presentation of the realities, challenges and possibilities of the American political system to bring an understanding, fascination and dedication to the wider public. The book analyses the transnational Alpine region where historical, social, and geo-economic specificities have led to a distinctive type of democracy and identity. Differentialist identities, multi-level consociational accommodation, and corporatist intermediation are typical features of this region's «consensual politics», and the process of European integration adds further to this complexity. These forms of consensual politics are challenged today by large and persistent populist parties that express strong anti-elitist sentiments, local identities, and Euro-sceptic attitudes. The book examines the defensive reaction of populist parties to the perceived threats of open borders (multi-culturalism and cheap labour) and elite negotiations (at all levels of governance). Protest attitudes translate into alternative views of European integration favouring proposals for an anti-assimilationist and labour protective «Fortress», as well as a religiously-based «Europe of the People». The book considers the possibility of a potential cleavage in the incipient European party system through alliances of «losers of integration» cutting across the left-right alignment and overlapping with ethno-linguistic, centre-periphery, religious, and rural-urban factors that survived in the Alpine region more than elsewhere. An empirical analysis by a group of international experts focuses on the Alpine areas of Austria, France, Germany, Italy, Slovenia, and Switzerland in which parties like FPÖ, CSU, Lega Nord, and Schweizerische Volkspartei have recently become crucial actors.

What are the conceptual and methodological challenges facing comparative politics today? This informative book discusses four main challenges that create stress for disciplinary reproduction and advancement, while providing potential solutions. In seven chapters, the contributors cover the most pressing issues: the dissolution of the nation-state as the main objective of inquiry; the increasing complexity of concepts and methods; the capacity to accumulate knowledge; and the tensions between parsimonious and contextually rich explanations. Scholars and students of comparative politics, international relations and political science will be interested in the up-to-date overview of pertinent conceptual problems, as well as the possible ways forward. Individual party members vary in their personal attributes, such as prior occupation, gender, and local experience. Parties seek to harness the attributes of their members by assigning them to committees where their expertise is relevant, and where they may enhance the party's policy brand.
