Well-armed drug traffickers had become the new lords of the favelas, protecting their turf through violence and patronage. By the early 1990s, the promise of the favela residents' mobilization of the late 1970s and early 1980s seemed out of reach. Yet the aspirations that fueled that mobilization have endured, and its legacy continues to shape favela politics in Rio de Janeiro.

This work uses Lourinhã's development as an example of the Portuguese experience to argue that the Carnation Revolution, although a watershed in Portugal's politico-cultural evolution, should not be understood as the moment when democracy came to Portugal.

Life after Dictatorship launches a new research agenda on authoritarian successor parties worldwide. Authoritarian successor parties are parties that emerge from authoritarian regimes, but that operate after a transition to democracy. They are one of the most common but overlooked features of the global democratic landscape. They are major actors in Africa, Asia, Europe, and Latin America, and they have been voted back into office in over one-half of all third-wave democracies. This book presents a new set of terms, definitions, and research questions designed to travel across regions, and presents new data on these parties' prevalence and frequent return to power. development had come to an end. Modern democracy began in Europe, but for hundreds of years it competed with various forms of dictatorship. Now, though, the entire continent was in the democratic camp for the first time in history. But within a decade, this story had already begun to unravel.
